JUDGMENT

The short issue that arises for decision in this writ petition is as to whether the private respondents, in-service candidates who possess diploma awarded by the Allahabad Agricultural Institute, are entitled to be considered for appointment by transfer as Dairy Extension Officers. They are Dairy Farm Inspectors in the Dairy Development Department. While in service, they underwent a course in the Allahabad Agricultural Institute and were awarded the diploma. The Government, however, took the view that such qualification possessed by them is not one recognised. They, therefore, moved this Court and Ext.R5(f) judgment was issued by this Court in O.P.No.3227/01. As rightly noticed by the learned Justice, the qualification prescribed for appointment by transfer and the qualification prescribed for direct recruitment in terms of Ext.P3 Special Rules are different. While possession of a degree in Dairy Science of a recognised University or of National Dairy

Research Institute under the Indian Council of Agricultural Research is required for considering an applicant for direct recruitment, a degree or diploma in Dairying from a recognised University or Institute is sufficient for consideration for appointment by transfer from among in-service candidates. The question, therefore, as to whether the diploma granted by the Allahabad Agricultural Institute is one to be recognised or not is squarely within the decision making authority of the Government.

2. Following the aforesaid judgment, the Government, having regard to the contents of the letter dated 19.3.2002 addressed by the Director of Dairy Development, considered the said issue and made Ext.P2 Government Order issuing its decision that the diploma possessed by the private respondents herein from the Allahabad Agricultural Institute is considered as the qualification for appointment by transfer to the post of Dairy Extension Officer. This means that the Government have decided that the diploma from the Allahabad Agricultural Institute is a

qualification recognised by the Government for appointment by transfer in terms of Ext.P3 Special Rules. May be that Ext.P2 order could have been expressed in better terms rather than state as if it applies only to the private respondents.

For the aforesaid reasons, the challenge against the impugned order fails. The writ petition is accordingly dismissed. No costs.
