Controversy in this writ petition pertains to filling up of seats in Diploma course in Dairy Science conducted by the fourth respondent University. According to the petitioner, though only 50% seats can be filled up by deputing instructors from the Dairy Development Department, the entire 30 seats were attempted to be filled up by such deputation.

2. Considering the said submission, this Court passed order dated 18.10.2011, calling upon the University to explain the steps it proposed to take to maintain the ratio 50:50 between the instructors deputed from the Department and the outside candidates. Accordingly, a statement has been filed on behalf of respondents 3 to 5, paragraphs 2 and 3 of which read thus:-

“2. It is pertinent to point out that however, taking into account the fact as evident from Ext.P6 the admission of 30 number of Dairy Farm Instructors is a matter subject to approval of academic council. That being so the University is willing to increase the seats to 60 by which 30 number of seats can be filled up from merit list and the rest 30 from the candidates who are deputed from Dairy Development Department. However, the increase in the said number of seats ought to be approved by the academic council. The University intends to place the matter before the academic council for appropriate orders. The same may be recorded and the writ petition may be closed.

3. It is pertinent to point out that even if the seats are increased to 60 seats, the petitioner has no chance to get admission since her rank is much below.”

3. From the above, it can be seen that the University is taking steps to maintain the ratio in terms of the
