ORDER

The candidates advised by the Kerala Public Service Commission, Thiruvananthapuram vide letter read as third above are hereby deputed for the pre-entry training of eight months with reference to the orders read above.

The candidates will report for training before the **Principal, Dairy Training Centre, Alathur, Palakkad** as per the list attached herewith on **22.11.2021 at 10 pm**. They should produce all necessary certificates in original to prove age & qualification, Passport size photographs (2 Nos.), Non-creamy layer Certificates (if any), Community Certificates (if any) enclosed proformas duly filled and the One-time Verification Certificate (received from KPSC) and Medical certificate (As prescribed in G.O. (P) No: 20/2011/P&ARD dated 30.06.2011) at the time of joining for training. They shall be paid an amount of 35,600/- [Rupees Thirty five thousand and six hundred only as per Ref No: (3) above] per month as consolidated allowance during the period of training. The period of training will not be reckoned for probation and increment. During the training period, the candidates are eligible for 12 days casual leave. Further leave if any availed by the candidates will be treated as Leave without allowance and the training period will be extended proportionately. The candidates should pass the theory examination and practical tests to be conducted after the completion of training. On successful completion of training they will be appointed in the post of Dairy Farm Instructors in the Department, in available vacancies. The Principal of Dairy Training Centre, Alathur, Palakkad shall depute the trainees for the field training in the respective Dairy Extension Service units mentioned in the list attached herewith and shall be intimated to the district officers.

In the case of trainee does not evince sufficient interest or does not make satisfactory progress in the training program or does not conduct himself/herself in a disciplined manner during the training will be terminated without notice. The loss incurred by the Government on account of such termination of training and also any loss that may be incurred by the

Government in the event of his/her voluntary withdrawal from training or any other act of commission and omission on his/her part during the training will be recoverable from him/her.

In case the candidate fails to report for training, his/her selection for appointment as Dairy Farm Instructor in Dairy Development Department is liable to be cancelled. The advice of the candidate is subject to the Rule 3 [c] of the General Rules of the Kerala State and Subordinate Service Rules, 1958.

The candidate are also directed to execute a bond for a sum of Rs. 40,000/- (Rupees Forty Thousand only) and a further sum of Rs. 10,000/- (Rupees Ten Thousand only) as liquidated damage together with interest at the usual bankrate in the prescribed proforma receive from Dairy Training Centre in the Kerala Stamp paper with a face value of Rs. 500/- (Rupees Five Hundred only) at the time of joining the pre-entry training.
