Eligibility Criteria

1. Warranty of the product should be for at least 1 year
2. The bidder should have experience in the supply of Aflatoxin M1 and Antibiotic kits for the last 3 years.
3. The turnover of the bidder should be at least 1 crore Rupees.

Mandatory documents required to be uploaded

Proposed product specifications shall be included as scanned signed copies in the e portal along with Tender

1. Covering Letter and authorization letter mentioning the participation in the tendering process.
2. General Information of the company and company profile, Company Registration details ,Legal identity
3. Detailed component wise technical specification of detection kits with readers for the qualitative analysis of antibiotics in milk, aflatoxin M1 in milk with brochures
4. Product certificate and Legal certifications (FSSAI/ILVO) for both Antibiotics and Aflatoxin M1 kits
5. Experience pertaining to supply of kits for at least 3 years.
6. No. of installations / Kits supplied nationwide during last 5 years with Customer reference list

7. No. of installations / Kits supplied in Kerala state during last 5 years
8. No. of installations / Kits supplied to Government firms / institutions last year
9. Copy of work orders (at least 5 no's) for last 2 years.
10. Details of service centers and service personnel in Kerala with contact details.
11. Warranty details offered (Minimum 1 year)
12. The additional Annual Maintenance Contract (AMC) conditions shall be attached as a document in the Technical Tender Document.
13. Details of Annual turnover for last 2 years.
14. If the supplier is not the original manufacturer, authorization certificate has to be submitted along with tender.
15. Undertaking that the Company will give necessary installation and training onsite.

Important Terms and Conditions:

1. Bids and Tender Documents, signed physically and/or digitally with a valid Digital Signature Certificate, are to be submitted online only in the designated covers on the official web portal of e Tenders Kerala.
2. Bidders who apply for qualitative analysis for both Aflatoxin M1 and antibiotics (BTS) in milk will only be considered for technical tender evaluation. Others will be rejected.
3. Evaluation of financial tender will be limited to only those applicants who are qualified in the technical tender evaluation procedure.
4. An authorization letter with signature attestation of the company representative attending the e-tender technical and financial evaluation process shall be furnished and uploaded.
5. Financial Bids should be uploaded only in the specific BOQ form available on the web portal against this Tender. Tenders, which are not in the prescribed BOQ form, are liable to be rejected.
6. Payment of the Total amount of EMD & Tender Fee should be made through Online Payment mode as a Single Transaction only. Late

and incomplete tenders and tenders without EMD will not be accepted.

7. Firms who are exempted from payment of EMD should upload attested copies of currently valued certificate from the Stores Purchase Department, Government of Kerala.
8. An agreement should be executed and signed by the Tenderer in the Kerala Stamp Paper of value Rs.50/-. A specimen form of agreement is given in the Tender Documents. Hard Copy of this agreement should be send to the Tender Inviting Authority on award of contract.
9. Online Opening of the Tenders will be done on the specified Date and Time through the official web portal of Tenders Kerala.
10. All items quoted must comply with the respective Specifications mentioned in the Tender notice and Bidders should upload the details and specifications of their items quoted.
11. The price quoted should be inclusive of packing and forwarding, freight, insurance, loading and unloading charges, site delivery, all taxes etc, up to the time when the unit is in full working condition.
12. The e-tender BOQ shall be Item "Rate Contract Type" and selection of L1 shall be based on the "total value of quoted rate". No separate item will be considered.
13. The District level Quality Control Officers shall be trained well to handle, operate and maintain the installed Antibiotic / Aflatoxin testing Instruments
14. The successful tenderer should supply the Items within 20 days of execution of agreement of contract and supply order to each district in Kerala.
15. Payment terms :- 100 % payment shall be made to the supplier (e payment) only after effective installation, testing and trial run of the testing unit, training to the Quality Control Officers and acceptance of the same by the users.
16. Price reduction on delayed delivery :- In case of delayed delivery, price reduction shall be applicable at the rate of 1% of the order value per week or part there of delay subject to a minimum of 10 % of the total order value.

17. Any litigation regarding the supply of equipment shall be subjected to Thiruvananthapuram district.
18. The Tender Inviting Authority (TIA) will not be responsible for any sort of the delay or the difficulties faced during the submission of bids through online by the bidders.
19. Director, DDD reserves the right to cancel the tender procedures at any point of e tendering procedure without any formal communication.
20. In addition to these all other General Conditions annexed in the Stores Purchase Manual of Government of Kerala are also applicable to this tender.
